ARTICLES OF ORGANIZATION

OF

MOORE & MOORE HOLDINGS, L. C.

The undersigned organizer, who is the authorized representative of the members of **MOORE & MOORE HOLDINGS, L.C.** (the "Company") under the Florida Limited Liability Company Act, hereby adopts the following Articles of Organization.

ARTICLE I - NAME

ARTICLE VI - ADDITIONAL MEMBERS

The members shall be entitled to admit additional members upon the consent of the Company's Board of Managers. Following the consent of the Board of Managers, any prospective member shall become a member upon payment of his, her or its contribution to the capital of the Company and upon such prospective member's agreement to comply with the Articles of Organization and Regulations of the Company.

ARTICLE VII - DISSOLUTION OF COMPANY

The death, retirement, resignation, expulsion, bankruptcy or dissolution of a member shall terminate the membership of that member in the Company. Upon the occurrence of any such event or any other that terminates the continued membership of a member in the Company, the Company shall be dissolved unless all of the remaining members consent to continue the existence of the Company.

ARTICLE VIII - MANAGERS

The management of the Company shall be vested in a Board of Managers as set forth in the Company's Regulations. The names and addresses of the initial members of the Board of Managers, who shall serve as the Board of Managers of the Company until their successors are elected and qualified, are set forth below:

ARTICLE X - AMENDMENT OF ARTICLES OF ORGANIZATION

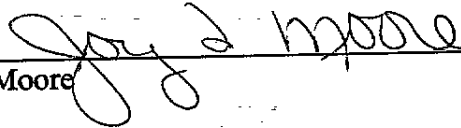
These Articles of Organization may be amended by majority vote of the voting members of the Board of Managers of the Company as provided in Chapter 608, Florida Statutes.
