ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

Article I - Name

The name of the limited liability company shall be **DOWNTOWN HAIR SALON, L.C.** ("Company").

Article II - Principal Place of Business and Address

The principal place of business and the address of the Company in Florida shall be 224 South Missouri Avenue, Lakeland, Florida 33801. The mailing address and the principal addresses are the same.

Article IV - Purposes and Powers

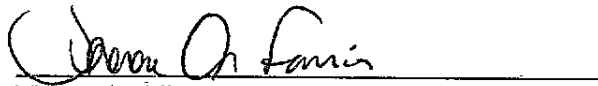
