ARTICLES OF ORGANIZATION**OF****DKB Realty, L.L.C.,

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. **NAME.** The name of the Limited Liability Company is DKB Realty, L.L.C. (the "Company").
2. **PERIOD OF DURATION.** The period of duration of the Company shall be perpetual.
