Name

The name of this limited liability company shall be HKSX INVESTMENT, L.L.C. (the "Company").

ARTICLE II

Duration

The period of duration for the Company shall be perpetual.

ARTICLE III

Right of Continuation

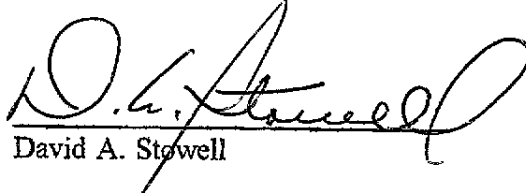

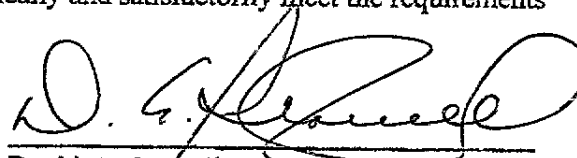
