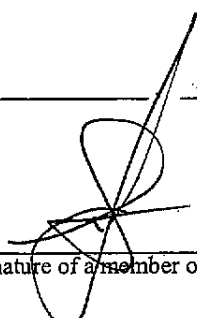

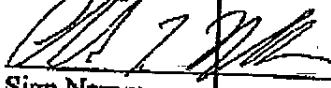
EXHIBIT "A"

As of the Effective Date, Southport Capital Corporation, a Delaware limited liability company, shall become the sole member and sole manager of the Company.

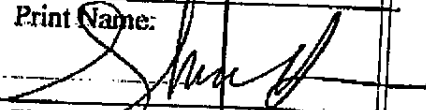

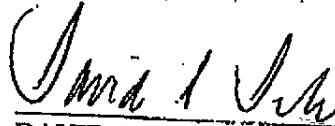
