ARTICLES OF ORGANIZATION OF AUTOSTAR USA, L.L.C.

"Limited Liability Company"

The undersigned organizer hereby forms a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (1997), and adopt as the Articles of Organization of such limited liability company the following:

Article I.

The name of the limited liability company shall be AutoSTAR USA, L.L.C. (the "Company")
