ARTICLE I. COMPANY NAME

ARTICLE II. COMMENCEMENT AND TERM OF EXISTENCE

ARTICLE XI. AMENDMENT TO ARTICLES OF ORGANIZATION

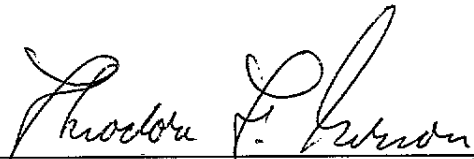
Members may adopt, alter, amend or repeal any provision of the Articles of the Organization by unanimous written consent of all the members of the Company.
