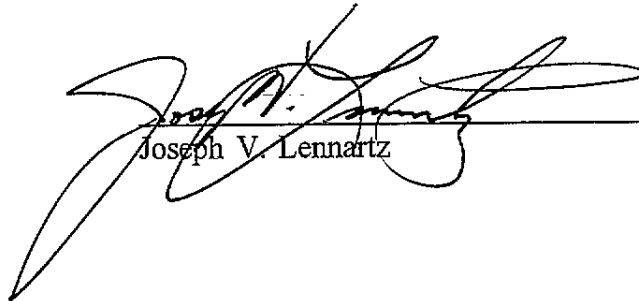
ARTICLE 6

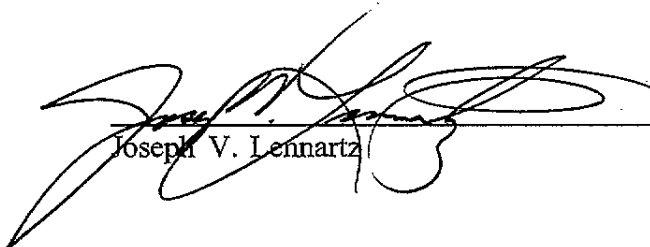
