ARTICLES OF ORGANIZATION

OF

T.R.T.E.N., L.L.C.

The undersigned, acting as the organizing Member of this limited liability company pursuant to Chapter 608 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such limited liability company:

ARTICLE I - NAME OF LIMITED LIABILITY COMPANY

The name of the limited liability company shall be T.R.T.E.N., L.L.C. (the "Company").

ARTICLE II - PERIOD OF DURATION

The period of duration for the Company shall commence with the filing of these Articles of Organization with the Secretary of State of the State of Florida, and shall continue until December 31, 2048, unless sooner dissolved pursuant to the Regulations, the Articles, or by operation of law.

ARTICLE III - ADDRESS

ARTICLE IV - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE V - MANAGMENT

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

New Members shall be admitted only with the consent of, and upon terms unanimously approved by, a majority of the Members.

ARTICLE VII - MEMBERS' RIGHT TO CONTINUE BUSINESS

In the event of the death, retirement, resignation, expulsion, withdrawal, bankruptcy or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued on approval of a majority of the remaining Members (other than the terminated Member and its successors-in-interest).


