# ARTICLES OF ORGANIZATION OF COMMUNITY ACQUISITIONS, L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

#### ARTICLE 1-NAME

The name of the limited liability company shall be Community Acquisitions, L.C. (hereafter "Company").

#### ARTICLE 2-ADDRESS

The mailing address and street address of the principal office of the Company shall be 201 NE 2nd Circle, Boca Raton, FL 33431.

#### ARTICLE 3-DURATION


