These Articles of Organization of **DEFT**, L.C., a Florida limited liability company (the "Company"), dated as of the 6th day of October 1998, are being duly executed and filed by Robert DeHarder, the organizer, authorized to form a limited liability company under the Florida Limited Liability Company Act (Chapter 608 of Florida Statutes) (the "Florida Act").

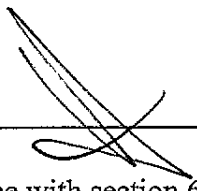
