# **ARTICLES OF ORGANIZATION**

### **UNIQUE BOATWORKS, L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be **UNIQUE BOATWORKS, L.C.**, ("Company").


### **ARTICLE 10 - MANAGEMENT**


