ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF PORT ORANGE MEDICAL CENTER, L.C.

The Articles of Organization of Port Orange Medical Center, L.C., a Florida limited liability company (the "Company"), originally organized as DeLand Professional Center, L.C., are amended as set forth in these Articles of Amendment:

- 1. The name of the Company, until amended as provided herein, is Port Orange Medical Center, L.C.
- 2. The date of filing of the Company's Articles of Organization, as DeLand Professional Center, L. C., was October 20, 1998.
- 3. The name of the Company was changed to Port Orange Medical Center, L.C. on May 24, 1999, by filing with the Florida Department of State, a certificate of amendment to the Company's articles of organization.
- 4. The purpose of these Articles of Amendment is to change the name of the Company from Port Orange Medical Center, L.C. to Port Orange Properties, L.C.
- 5. Article I of the Articles of Organization of the Company, as previously amended, is hereby further amended to read as follows:

"ARTICLE 1 NAME

The name of this company is Port Orange Properties, L.C."

 - 7. This amendment is made pursuant to Section 608.411, Florida Statutes.
