**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION OF
PORT ORANGE MEDICAL CENTER, L.C.**

The Articles of Organization of Port Orange Medical Center, L.C., a Florida limited liability company (the "Company"), originally organized as DeLand Professional Center, L.C., are amended as set forth in these Articles of Amendment:

1. The name of the Company, until amended as provided herein, is Port Orange Medical Center, L.C.
2. The date of filing of the Company's Articles of Organization, as DeLand Professional Center, L. C., was October 20, 1998.
3. The name of the Company was changed to Port Orange Medical Center, L.C. on May 24, 1999, by filing with the Florida Department of State, a certificate of amendment to the Company's articles of organization.
4. The purpose of these Articles of Amendment is to change the name of the Company from Port Orange Medical Center, L.C. to Port Orange Properties, L.C.
5. Article I of the Articles of Organization of the Company, as previously amended, is hereby further amended to read as follows:

"ARTICLE 1
NAME

The name of this company is Port Orange Properties, L.C."

6. This amendment was adopted by the members of the Company on the date of execution of these Articles of Amendment, and the number of votes cast for the amendment by the members was sufficient for approval.

7. This amendment is made pursuant to Section 608.411, Florida Statutes.
8. This amendment is effective immediately upon being filed with the Florida Department of State.
