ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF PORT ORANGE PROPERTIES, L.C.

The Articles of Organization of Port Orange Properties, L.C., a Florida limited liability company (the "Company"), as previously amended, are further amended as set forth in these Articles of Amendment:
