**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF ORGANIZATION
OF
FOREST HILLS PROPERTIES, L.C.**

FOREST HILLS PROPERTIES, L.C., a limited liability company organized and existing under the laws of the State of Florida (the "Company"), in order to amend its Articles of Organization as now in effect (the "Articles of Organization"), in accordance with the requirements of Section 605.0202, Florida Statutes, does hereby certify as follows:

1. The name of the Company is **FOREST HILLS PROPERTIES, L.C.**, and its Document Number with the Florida Department of State is 1.98000002386.

2. The Articles of Organization were filed with the Florida Department of State on October 23, 1998.

3. These Articles of Amendment to the Company's Articles of Organization shall be effective immediately upon filing hereof with the Florida Department of State.

4. The Articles of Organization are hereby amended by deleting Articles III and IV, and substituting therefor the following:

ARTICLE III

Duration

The period of duration for the Limited Liability Company shall be extended for an additional thirty (30) years (October 23, 2048), unless sooner dissolved or terminated.

ARTICLE IV

Management

The Limited Liability Company shall be managed by a manager. The sole manager of the Limited Liability Company shall be:
