ARTICLES OF ORGANIZATION
OF
CAPTUS COMMUNICATIONS INTERNATIONAL, L.L.C.

These Articles of Organization of **CAPTUS COMMUNICATIONS INTERNATIONAL, L.L.C.**, a Florida limited liability company (the "Company"), dated as of the 20th day of October, are being duly executed and filed by Guilhem Castagne, the organizer, authorized to form a limited liability company under the Florida Limited Liability Company Act (Chapter 608 of Florida Statutes) (the "Florida Act").

FIRST: The name of the limited liability Company is **CAPTUS COMMUNICATIONS INTERNATIONAL, L.L.C.**

SECOND: The nature of the business to be transacted and the purposes to be promoted or carried out by the Company, is to engage in any lawful act or activity for which limited liability companies may be formed under the Florida Act, and by such statement all lawful acts and activities shall be within the purposes of the Company's business as permitted under the Florida Act.

THIRD: The Company is to be managed by managers who together form a committee (the "Management Committee"), and who shall serve in this capacity until the first annual meeting or until their successors are duly elected and qualified. The names and addresses of the initial managers on the Management Committee are set forth on Exhibit A, attached hereto and made a part hereof.

FOURTH: The duration of the Company shall be perpetual, and shall begin on the date these Articles of Organization are duly filed with the Secretary of State of the State of Florida.

FIFTH: The principle and mailing address of the Company is 15 Ambleside Drive, Belleair, Florida 33756.

SIXTH: The Members of the Company (the "Members") may admit additional members as provided in that certain Limited Liability Company Operating Agreement dated as of 20th day of October, 1998. (the "Operating Agreement").

SEVENTH: The remaining Member(s), if any, pursuant to the terms of the Operating Agreement, may elect to continue the Company's business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company.

EIGHTH: The Registered Agent and Registered Office for service of process is as follows:

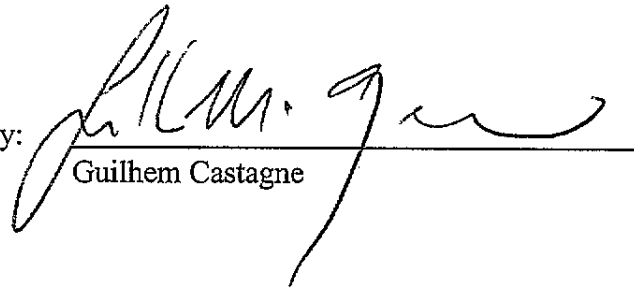

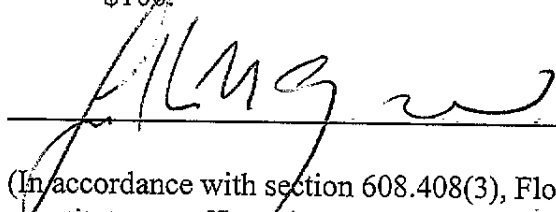
