ARTICLES OF ORGANIZATION

OF

GREGORY W. STONER, L.C.
A Limited Liability Company

The undersigned, who is duly licensed to practice law in the State of Florida, desiring to form a limited liability company in accordance with Chapter 608 of the Florida Statutes and the Florida Professional Service Corporation and Limited Liability Company Act, adopt the following Articles of Organization:

ARTICLE I

Name

The name of the limited liability company ("Company") is Gregory W. Stoner, L.C.

ARTICLE II

Address

Duration

This provision shall not be applicable to the extent it is in conflict with the law or the professional rules of legal practice.

ARTICLE VI

Registered Agent and Office
