# ARTICLES OF ORGANIZATION OF M & G/SAN BAO INVESTMENTS, L.L.C.

The undersigned member, acting as a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, adopts the following Articles of Organization:

#### ARTICLE I

#### <u>Name</u>

The name of this limited liability company is M & G/SAN BAO INVESTMENTS L.C.C. (the "Company").

#### <u>ARTICLE II</u>

#### <u>Duration of Existence</u>

The Company shall commence its existence on October 19, 1998 and thereafter shall remain in existence until such time as the occurrence of any dissolving event defined in the Company's Regulations.

#### ARTICLE III

#### Purpose of Organization

The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under Florida law.

#### ARTICLE IV

#### Mailing and Street Address; Initial Registered Agent

The Company's initial mailing and street address is 2411 Carolina Avenue, Tampa, FL 33629, and its initial registered agent is Richard B. Hadlow, whose address is 220 South Franklin Street, Tampa, Florida 33602.

#### ARTICLE VIII

#### Regulations

The power to adopt, alter, amend or repeal regulations governing the operation of the Company shall be vested in its members.

### ARTICLE IX

#### Indemnification

If in the judgment of all of the members, the criteria set forth in §608.4363, Florida Statutes, or any successor statute, have been met, then the Company shall indemnify any manager or member, or former manager or member, his or its personal representatives, devisees or heirs, in the manner and to the extent contemplated by the §608.4363, Florida Statutes.

## Additional Members

The members are authorized to admit additional members in the manner set forth in the Company's Regulations.

#### ARTICLE VI

## Continuation of the Company

The Company shall not automatically terminate upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, provided that the member whose membership is terminated is not a manager of the Company. Upon termination of the membership of a member who is a manager, the Company will automatically terminate, provided that the holders of a majority of the then outstanding Units (as that term is defined in the Company's Regulations) of the Company shall have the right to continue the business of the Company.

## ARTICLE VII

## Management of the Company

The Company shall be managed by a Manager who shall be elected annually by the Members in the manner set forth in the Company's Regulations. The following individual is hereby appointed the initial manager of the Company, to serve until his successor is duly elected, qualified, and seated:


