ARTICLE I - Name:

The name of the Limited Liability Company is: JJ SCHOOL OF RIDING, L.C.

ARTICLE II - Address:

ARTICLE III - Duration:

The Period of duration for the Limited Liability Company shall be: 30 years from the date that the articles of organization are filed with the Secretary of State for the State of Florida.

ARTICLE IV - Management:

In addition, the company shall pay for or reimburse any expenses incurred by such persons who are parties to such proceedings, in advance of the final

disposition of such proceedings, to the full extent permitted by the Florida Limited Liability Company Act.

ARTICLE VII - Members Right to Continue Business:

The right of the remaining members of the Limited Liability Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company shall be: The business of the Limited Liability Company may be continued by the consent of all the remaining members.
