## ARTICLES OF ORGANIZATION

OF

### **PALM DISTRIBUTING, LLC** **A Limited Liability Company**

THE UNDERSIGNED, in order to form a limited liability company, pursuant to the Florida Limited Liability Company Act, Fla. Stat. Ch. 608.401 et. seq. (1993) respectfully states as follows:

1. Name. The name of the limited liability company shall be "Palm Distributing, LLC".
2. Duration. The duration of the limited liability company shall be no longer than May 1, 2048.
3. Purpose. The purpose of the limited liability company shall be to engage in the business of distributing beverages and food products, but this statement of purpose shall not restrict the limited liability company from engaging in any lawful business which the Members of the limited liability company deem appropriate.

7. Additional Members. Additional Members of the limited liability company may be admitted if each such additional Member agrees to be bound by the Operating Agreement of the limited liability company and all Members unanimously consent to the admission of each such additional Member.

8. Dissociation. Upon an event of dissociation, the Members of the limited liability company may continue the business of the limited liability company if a majority of the Members holding a majority of the interest in the limited liability company vote in favor of continuing the business of the limited liability company.

9. Management. The management of the limited liability company shall be vested in the Members collectively.

10. Operating Agreement. The operation of the limited liability company shall be governed according to the provisions of an Operating Agreement executed by all Members which shall be continuously on file at the registered office.
