## **ARTICLES OF ORGANIZATION**

**OF**

### **APOSTOLIC PLAZA, L.L.C.**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

#### **ARTICLE I - NAME**

The name of the limited liability company is APOSTOLIC PLAZA, L.L.C. (the "Company").

## ARTICLE VII - MEMBER RIGHTS TO CONTINUE BUSINESS

The remaining members of the Company shall have the right to continue the business of the Company on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of member in the Company.

## ARTICLE VIII - REGISTERED AGENT
