**ARTICLES OF ORGANIZATION
OF GABRIEL WIRELESS, L.L.C.**

The undersigned member of this limited liability company hereby certifies the following for purposes of forming the limited liability company under the laws of the State of Florida. The following Articles shall be the charter and authority for the conduct of business of such limited liability company.

ARTICLE I

NAME

The name of the limited liability company shall be GABRIEL WIRELESS, L.L.C.

ARTICLE II

A member's interest in the limited liability company may not be sold or otherwise transferred except as provided in the regulations and operating agreement.

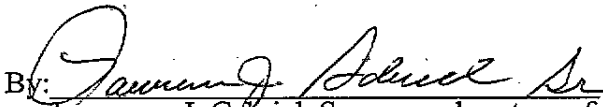
ARTICLE VII
