# **ARTICLES OF ORGANIZATION**

## **OF**

### **THE MANAGEMENT GROUP WORLDWIDE, L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be **THE MANAGEMENT GROUP WORLDWIDE, L.C.**, ("Company").

#### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 4024 72nd Avenue East, Sarasota, Florida 34234 and the mailing address shall be the same.

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.


