# ARTICLES OF ORGANIZATION OF MAX-CASH, L.L.C.

W. Todd Schweizer, a natural person competent to contract, presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, Florida Statutes.

#### ARTICLE I - NAME

The name of this limited liability company is: MAX-CASH, L.L.C.

This limited liability company is referred to articles as "the Company."

### ARTICLE II - PRINCIPAL OFFICE ADDRESS
