Additional members may be admitted to the limited liability company upon the unanimous agreement of all members of the limited liability company.


ARTICLE VI - CONTINUATION OF BUSINESS

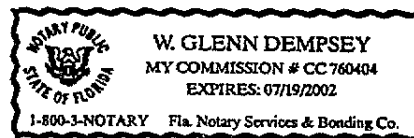



BEFORE ME, the undersigned authority, personally appeared Kai Eichberg, who being duly sworn according to law, stated the following:

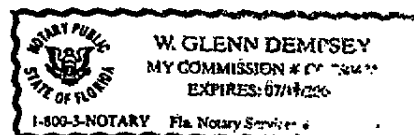
1. That he is the manager and sole member of NEW LIFE CHRONO THERAPY, L.L.C. (hereinafter referred to as the "limited liability company").
