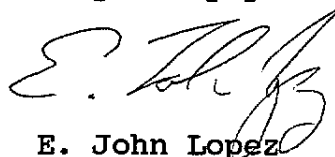

ARTICLES OF ORGANIZATION
OF
MARKETING COMMUNICATIONS CENTERS INTERNATIONAL, LLC

The undersigned person, acting as the organizer of MARKETING COMMUNICATIONS CENTERS INTERNATIONAL, LLC under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:
