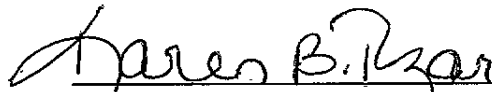

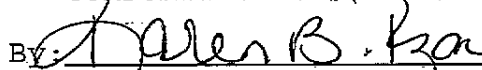

LIMITED POWER OF ATTORNEY

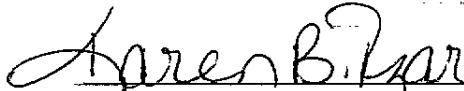
