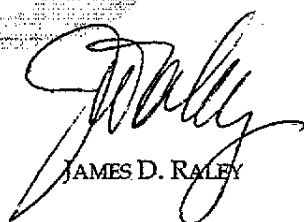

The undersigned individuals of a limited liability company formed under the State Florida Limited Liability Company Act, Sections 608.401 – 608.514, Florida State Statutes, hereby adopt the following Articles of Organization:

1. **Name** – The name of the limited liability company is: Origin Technologies International, LLC.
2. **Duration** – The period of duration for this limited liability company is 30 years from the date of filing the Articles of Organization with the Florida Department of State, unless sooner dissolved by the members of as provided by Florida State law.
3. **Purpose** – The purpose for which this limited liability company is organized is to perform any lawful purpose except that of banking, insurance, or accounting.

7. **Additional Capital Contribution of Members** – Additional capital contributions of members shall not be required.
8. **Admission of Additional Members** – Additional members may be admitted to this LLC only with and upon such terms unanimously agreed to by all Members in the Operating Agreement.
9. **Continuation** – The remaining Members of the limited liability company by unanimous vote may exercise the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any other event which terminates the continued membership of a

Member in this limited liability company. Individual Members cannot enter into a Business Continuation Agreement.

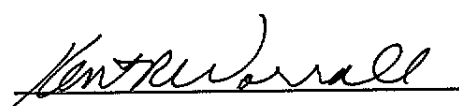
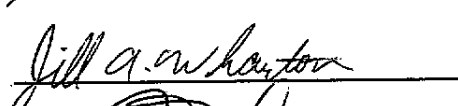
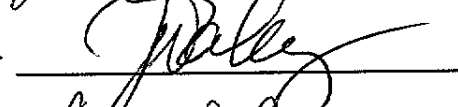
