

ARTICLES OF MERGER

HAGAN ACE HARDWARE OF MACCLENNY, L.L.C.

Pursuant to the pertinent provisions of Chapter 607 and Chapter 608, Florida Statutes, the undersigned Corporation and the undersigned Limited Liability Company hereby adopt the following Articles of Merger:

ARTICLE I

Hagan Ace Hardware of Orange Park, Inc., a Florida corporation, having document number 413108, and Hagan Ace Hardware of Macclenny, L.L.C., a Florida limited liability company, having document number L98000002930, hereby adopt these Articles of Merger for the purpose of merging Hagan Ace Hardware of Orange Park, Inc. into Hagan Ace Hardware of Macclenny, L.L.C., and thereafter Hagan Ace Hardware of Macclenny, L.L.C. shall be the surviving limited liability company.

ARTICLE II

Under that certain Plan and Agreement of Merger, dated November 1, 2007, by and between, Hagan Ace Hardware of Orange Park, Inc., and Hagan Ace Hardware of Macclenny, L.L.C., (which is incorporated herein
