## ARTICLES OF ORGANIZATION OF SOUTHERN GROVE III, LLC

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization.

## ARTICLE I NAME

The name of the Limited Liability Company shall be: SOUTHERN GROVE III, LLC.

# ARTICLE II ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is: 117 Bouganvilla Drive, Ponte Vedra Beach, Florida 32082.

## ARTICLE III PURPOSE
