ARTICLES OF ORGANIZATION OF CELEBRITY HOST, L.C.

The undersigned Member adopts the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

ARTICLE I. NAME OF COMPANY
