Article I Name

Article IV Initial Registered Office and Agent

<u>Article V</u> Share Certificates

The Company shall terminate upon the consent of all Members or as otherwise provided in accordance with the terms of the Operating Agreement.

Article VIII Management

(a) Number. This company shall initially be managed by one (1) or more managers elected by the Members. The number of managers may be increased or diminished from time to time by the members. The managers hereby appointed by the members shall serve until the first annual meeting of the members, or until their successors are elected and qualify.
