ARTICLES OF ORGANIZATION

OF

NATIONAL HOSPITALITY, LLC

ARTICLE I

Name and Duration

The name of this Limited Liability Company is National Hospitality, LLC (hereinafter referred to as the "Company"). The duration of the Company shall commence upon the filing of these Articles of Organization and shall be perpetual.

ARTICLE II

Principal Office

The mailing address and street address of the principal office of the Company is 678 Blairshire Circle, Winter Park, Florida 32792, or such other place as the Members of the Company may determine from time to time.

ARTICLE III

Registered Office and Agent

ARTICLE IV

Initial Members: Ownership Interests

The name and address of the initial members of the Company (each a "Member") are:

ARTICLE V

Management

The management of the Company shall be reserved to the members. The Trust, named as an initial Member, shall serve as the initial managing member until the first annual meeting of the Members. The Members may elect, by an affirmative vote of a majority in interest of the Members, additional managing members of the Company to conduct the business affairs of the Company, all in accordance with the Regulations. The term "majority in interest" as used in these Articles shall mean a majority of the outstanding ownership interest in the Company held by the Members entitled to vote or consent.

ARTICLE VI

Admission of Additional Members

Additional members may be admitted from time to time only upon the consent of a majority in interest of the Members, and the managing members shall determine the amount and nature of contributions by additional members at the time the additional members are admitted.

ARTICLE VII

Continuation of Business

The remaining members of the Company shall have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a member in the Company so long as the consent of a majority in interest of the remaining Members is obtained within thirty (30) days after the occurrence of one of the foregoing events.
