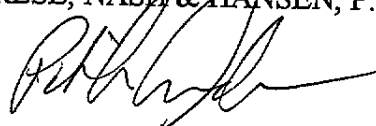

All remaining property and assets of the Company have been distributed among its Members in accordance with their respective rights and interests.

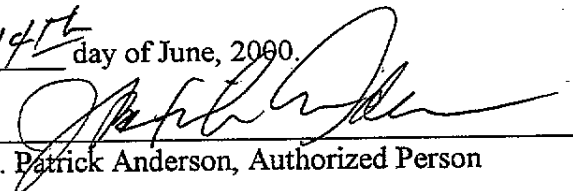
**ARTICLE VII**
