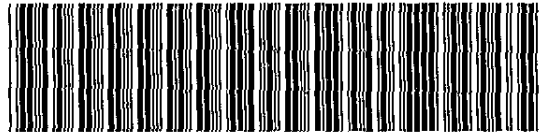

IN WITNESS WHEREOF, the managing member, holding all interest in the company, approves this dissolution.




