ARTICLES OF ORGANIZATION OF COMMONWEALTH LLC

Pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, the following are the Articles of Organization for Commonwealth LLC (the "Company"):

1. Name and Principal Place of Business. The name of the Company is Commonwealth LLC, and its mailing address and principal office shall be located at 569 Edgewood Avenue South, Jacksonville, Florida 32205.

2. Commencement and Duration of Existence. The Company shall exist perpetually from the date of its commencement, which shall be the date of filing of these Articles with the Florida Secretary of State. The Company's existence shall terminate in the manner provided by law or as provided in the regulations adopted by the member(s) of the Company.

3. Purposes and Powers. The purpose for which the Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Company shall have all of the powers vested in a Limited Liability Company organized and existing by virtue of such laws.

4. Initial Registered Agent. The name and address of the initial registered agent in Florida for the Company are: Donald W. McArthur, III, 569 Edgewood Avenue South, Jacksonville, Florida 32205.

5. Admission of Additional Members. Additional members may be admitted as members of the Company upon unanimous agreement of the then existing member(s) of the Company.

6. Continuation of Business. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company the remaining member(s) shall have the right to elect, within 90 days after the occurrence of such event, to continue the business of the Company.

7. Management. The Company is to be managed by the members (the "Managing Member") and the name and address of the initial Managing Member are:
