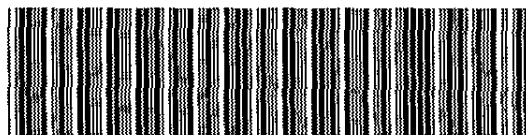

These Amended and Restated Articles supersede and substitute the Articles of Organization of the Company previously filed with the State of Florida on December 11, 1998, as amended.

Registered Office and Registered Agent




