**ARTICLES OF ORGANIZATION OF
OVERSTREET TIMBER PRODUCTS, L.C.**

1. Name. The name of the limited liability company (hereinafter "company") is: OVERSTREET TIMBER PRODUCTS, L.C.
2. Existence. The company shall have perpetual existence. The company shall commence existence on December 11, 1998.
3. Location. The street address of the principal office of the company is PO Box 257, Highway 129 South, Trenton, FL 32693. The mailing address of the company is PO Box 257, Trenton, FL 32693.
4. Registered Agent. The initial street address in the State of Florida of the initial registered office of the company is PO Box 257, Highway 129 South, Trenton, FL 32693 and the name of its initial registered agent at such address is Louis T. Overstreet.
5. Additional Members. The members may admit such additional members on such terms and conditions as they may unanimously agree.
6. Continuation. A majority of the remaining members of the company shall have the right to continue the company in existence on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the company.
7. Management. The company shall be managed by one or more managers as set forth in the Regulations. 
