ARTICLES OF ORGANIZATION OF
BELFORT ROAD SOUTH PROFESSIONAL PARK, L.L.C.

ARTICLE I

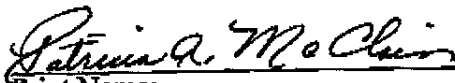
