AMENDED AND RESTATED ARTICLES OF ORGANIZATION

OF

ANRO OF FLORIDA, L.L.C.

Pursuant to the provisions of Section 608.411 of the Florida Statutes, AnRo of Florida, L.L.C., a Florida limited liability company which filed its original Articles of Organization on December 22, 1998, hereby adopts the following Amended and Restated Articles of Organization of AnRo of Florida, L.L.C.:

ARTICLE I - Name

The name of the limited liability company is AnRo of Florida, L.L.C. (the "Company").

ARTICLE II - Address of Principal Office

The mailing address and street address of the principal office of the Company is: 2414 Mandan Trail, Winter Park, Florida 32789.

ARTICLE III - Duration

The term of existence of the Company commenced on December 22, 1998, with the filing of the Articles of Organization with the Secretary of State of the State of Florida, and shall continue until December 31, 2050, unless sooner dissolved pursuant to the Articles of Organization or Regulations of the Company, or by operation of law.

ARTICLE IV - Management

The Company is to be managed by a Manager or Managers. The name and address of the initial Manager is as follows:

ARTICLE V - Admission of Additional Members

New Members shall be admitted only with the consent of, and upon terms approved by, the Members that hold a majority of the interests in the Company.

ARTICLE VI - Members' Rights to Continue Business

In the event of the death, retirement, resignation, expulsion, withdrawal, bankruptcy or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued on approval of the Members (other than the terminated Member and such Member's successors-in-interest) that hold a majority of the interests in the Company as determined without taking into account the terminated Member and such Member's successors-in-interest.

ARTICLE VII - Registered Office and Registered Agent

The street address of the registered office of the Company in the State of Florida is 2414 Mandan Trail, Winter Park, Florida 32789. The name of the registered agent of the Company at that address is Ron Stocknopf Ben-Zeev.
