# AMENDED AND RESTATED ARTICLES OF ORGANIZATION

Pursuant to the provisions of Section 608.411 of the Florida Statutes, AnRo of Florida, L.L.C., a Florida limited liability company which filed its original Articles of Organization on December 22, 1998, hereby adopts the following Amended and Restated Articles of Organization of AnRo of Florida, L.L.C.:

#### ARTICLE I - Name

The name of the limited liability company is AnRo of Florida, L.L.C. (the "Company").
