AMENDED AND RESTATED ARTICLES OF ORGANIZATION

Pursuant to the provisions of Section 608.411 of the Florida Statutes, AAA Development, L.L.C., a Florida limited liability company which filed its original Articles of Organization on December 22, 1998, hereby adopts the following Amended and Restated Articles of Organization of AAA Development, L.L.C.:

ARTICLE I - Name

The name of the limited liability company is AAA Development, L.L.C. (the "Company").

ARTICLE II - Address of Principal Office
