LEGAL DRAFTING, L.L.C. ARTICLES OF ORGANIZATION

The undersigned, being a member of the company, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is LEGAL DRAFTING, L.L.C. (the "Company").

ARTICLE II. ADDRESS

The Company's principal street address and mailing address is 92 Lake Wire Drive, Lakeland, Florida 33815.

ARTICLE III. DURATION AND CONTINUATION
