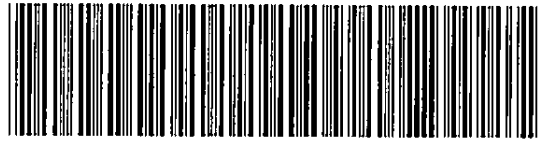

GLICKSMAN & MARS DENTAL, LLC**

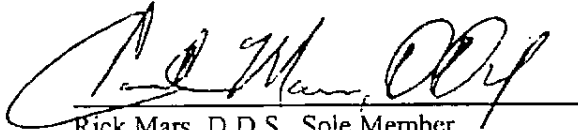
