ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Chapter 608 of the Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of FAIR FIELD PRESS, L.L.C., a Florida limited liability company (the "Company").

ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Company is FAIR FIELD PRESS, L.L.C., and its principal office or mailing address is 1345 16th Street North, St. Petersburg, Florida 33705.

ARTICLE 2: DURATION

This Company shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.

ARTICLE 3: INITIAL REGISTERED OFFICE AND AGENT
