**ARTICLES OF ORGANIZATION OF
DRS. CAMERON AND KRYNAUW, L.L.C.**

The undersigned hereby forms and establishes a limited liability company effective January 1, 1999 pursuant to Chapter 608, Florida Statutes as follows:

ARTICLE I

The name of this limited liability company is DRS. CAMERON AND KRYNAUW, L.L.C.



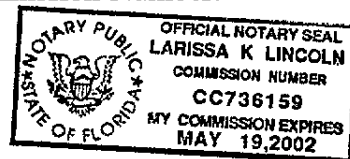
