**ARTICLES OF ORGANIZATION
OF
M-VENTURES, L.L.C.**

The undersigned Member signs these Articles of Organization and forms a limited liability company (the "Company") pursuant to the provisions of the Florida Limited Liability Company Act (the "Act"), as follows:

Article 1. Name. The name of the Company is:

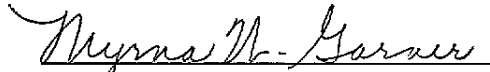
