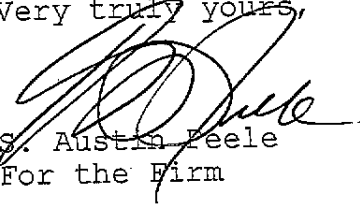

ARTICLES OF ORGANIZATION

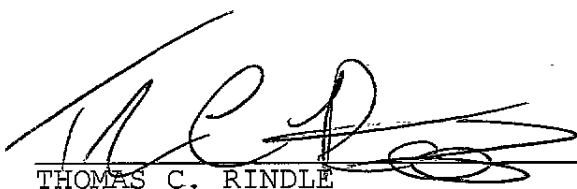

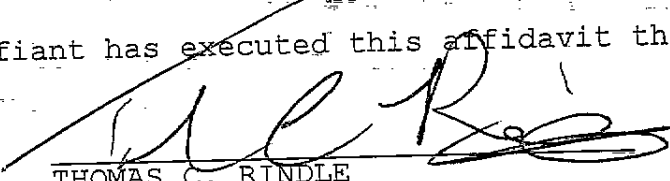
2. The Affiant is the sole member of the Company as of the date hereof.

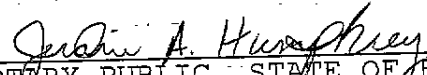
