ARTICLES OF ORGANIZATION OF NUMBERING & CODING ASESORES, L.L.C.

The undersigned certify that we have associated ourselves together for the purpose \mathfrak{G} becoming a limited liability company under the laws of the State of Florida, Florida Statute 608_{-5} Florida Limited Liability Company Act, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. 6. ARTICLE V MEMBERSHIP RESTRICTIONS
